**Your rights may be affected by a proposed settlement in a class action case pending in Los Angeles County Superior Court, State of California, Case No. BC 227267**

The Los Angeles Superior Court has tentatively approved a settlement in a class action lawsuit that alleges that certain mortuaries failed to warn their clients that current and former owners of Woodlawn Memorial Park, located at 1715 Greenleaf Boulevard, Compton, California, engaged in improper burial and other related practices in violation of various licensing and statutory requirements. The settling defendants deny all liability. The Court has not yet ruled, one way or the other, on the merits of the claims.

The proposed settlement makes available \$45,250.00 to complete the restoration of Woodlawn. The primary claims against the cemetery were settled in 2004. You may object, but you may not be excluded from the settlement. The last day to serve and file with the Court listed below any comments in support of or in opposition to the settlement is January 20, 2009. Settlement Class Counsel will seek a total award of attorneys' costs of no more than \$89,750.00 from the settlement funds. Attorneys' fees are not sought. This notice is a summary only.
