**NOTICE OF POTENTIAL DISCLOSURE OF PERSONAL
CONTACT INFORMATION**

TO: ALL PERSONS EMPLOYED BY DIVA LIMOUSINE AS LIMOUSINE DRIVERS AT ANY TIME DURING THE PERIOD OF MAY 10, 2002 TO THE PRESENT.

PLEASE READ THIS NOTICE CAREFULLY; IT CONCERNS THE POTENTIAL DISCLOSURE OF YOUR CONTACT INFORMATION TO THE ATTORNEYS FOR CLASS PLAINTIFF SARKIS GHAZARYAN.

I. PURPOSE OF THIS NOTICE.

SARKIS GHAZARYAN worked as a limousine driver for DIVA LIMOUSINE. His attorneys have requested that DIVA LIMOUSINE provide them with the contact information (home addresses and telephone numbers) for all persons employed by DIVA LIMOUSINE as limousine drivers at any time during the period of May 10, 2002 to the present.

On May 10, 2006, GHAZARYAN filed a Complaint against DIVA LIMOUSINE in the Los Angeles County Superior Court, seeking to represent a class consisting of all persons who were employed as limousine drivers at any time during the period of May 10, 2002 to the present and who allegedly were not paid proper compensation for all hours worked, including overtime, and who allegedly were not provided with statutorily mandated meal and rest breaks. DIVA LIMOUSINE denies any liability or wrongdoing of any kind associated with any of the claims alleged in the Lawsuit.

II. YOUR OPTIONS REGARDING DISCLOSURE OF YOUR CONTACT INFORMATION.

If you were employed by DIVA LIMOUSINE as a limousine driver at any time during the period of May 10, 2002 to the present, you have two (2) options regarding the disclosure of your contact information to attorneys for GHAZARYAN. Your rights and the procedure to select an option are as follows:

A. Option One: You Can Do Nothing

If you do not return the enclosed Objection Form by **June 14, 2007**, your address and telephone numbers will be provided to the attorneys for GHAZARYAN. Please note that even if this happens, it does not obligate you to speak with any attorneys.

B. Option Two: You Can Object To The Disclosure Of Your Contact Information

If you do not want your home address and telephone number disclosed, you may object by completing the enclosed Objection Form and returning it to the Contact Administrator postmarked no later than **June 14, 2007**. You must date and sign the Objection Form for your objection to be valid.
